GuocoLeisure Assets Limited ("GLAL") ceases to have any interests in the 1,075,950,434 shares in GL Limited ("GL") following its acceptance tendered on 30 March 2021 in respect of the voluntary cash offer (the "Offer") by GuocoLeisure Holdings Limited ("GLHL") for the shares of GL at the final offer price of S\$0.80 per share. GLHL has direct interest in 201,514,590 shares in GL and deemed interest in 1,101,127,593 shares in GL (shares tendered in acceptance of the Offer and yet to be settled). As GLAL and GLHL are wholly-owned subsidiaries of Guoco Group Limited ("GGL"), GGL is deemed to be interested in the interest of GLAL and GLHL in the shares of GL by virtue of Section 4 of the Securities and Futures Act (Cap. 289).
